The Hon'ble Supreme Court vide its judgment in Writ Petition(Civil) No. 274 of 2014 dated 17th March, 2015 has set aside and quashed reservation given to Jat Community in the Central list of OBC category for the States of Bihar, Gujarat, Haryana, Himachal Pradesh, Madhya Pradesh, NCT of Delhi, Bharatpur & Dholpur Districts of Rajasthan, Uttar Pradesh and Uttarakhand. Hence, candidates belonging to the Jat community, who had applied & have been shortlisted for interview under OBC category from these States, will be considered under General category while drawing the merit list for final selection.

Appearing in the Interview will not automatically confer any right of being selected for the said post.
